- 2. The note was issued in the original principal amount of \$250,000. The outstanding principal and accrued interest on such note will automatically convert into shares of common stock, par value \$0.001 per share, of Gemphire Therapeutics Inc. (the "Company") immediately prior to the closing of the Company's initial public offering. The note bears interest at a rate of 8% per annum. The note has accrued interest of \$13,041 to date and will continue to accrue interest until conversion.
