1. The Series A Convertible Preferred Stock has no expiration date, and shall convert into shares of common stock, par value \$0.001 per share, of Gemphire Therapeutics Inc. (the "Company") on a one-for-one basis immediately prior to the closing of the Company's initial public offering.

2. These shares are indirectly owned by the reporting person as trustee of The Charles L. Bisgaier Trust.

3. The notes were issued in the original principal amount of \$125,000. The outstanding principal and accrued interest on such notes will automatically convert into shares of common stock, par value \$0.001 per share, of the Company immediately prior to the closing of the Company's initial public offering. The notes bear interest at a rate of 8% per annum. The notes have accrued interest of \$3,781 to date and will continue to accrue interest until conversion.

4. The notes were issued in the original principal amount of \$100,000. The outstanding principal and accrued interest on such notes will automatically convert into shares of common stock, par value \$0.001 per share, of the Company immediately prior to the closing of the Company's initial public offering. The notes bear interest at a rate of 8% per annum. The notes have accrued interest of \$8,132 to date and will continue to accrue interest until conversion.
